## JOINT CAUTIONARY ANNOUNCEMENT

Further to the cautionary announcements issued in the context of the proposed restructuring and reorganisation through a scheme of arrangement (the "Scheme"), the Boards of Directors of ENL Limited ("ENL"), of Rogers and Company Limited ("Rogers") and of NewENLRogers Limited ("NewENLRogers") are pleased to inform the shareholders and the public in general that the Supreme Court has, on 27 June 2025, sanctioned the Scheme with an effective date of 30 June 2025.

The implementation of the Scheme will entail the following:

- A demerger of ENL into ENL post-Scheme and NewENLRogers through the vesting by the Supreme Court, of the investments and liabilities of ENL (including the listed notes issued by ENL under Tranche Reference Numbers ENL-01-FRN-122028, ENL-01-FLN-122030 and ENL-01-FLN-122038) into NewENLRogers;
- The listing of NewENLRogers on the Stock Exchange of Mauritius (the "SEM");
- The issue of 367,435,964 Ordinary Shares and 700,000,000 Restricted Redeemable Shares of NewENLRogers to the shareholders of ENL on a 1:1 basis, such that the shareholders of ENL will have the same shareholding in NewENLRogers as in ENL;
- The acquisition of Rogers Corporate Services Ltd ("RCSL"), a wholly-owned subsidiary of Rogers owning 25.38% of Societé Helicophanta, by ENL from Rogers, in consideration for 48,526,710 ENL Ordinary A Shares;
- The distribution by Rogers of the said 48,526,710 ENL Ordinary A Shares to its shareholders, being NewENLRogers and the minority shareholders of Rogers;
- The distribution by NewENLRogers of 28,984,928 ENL Ordinary A Shares received from Rogers to NewENLRogers shareholders such that for every Ordinary Share held in NewENLRogers, the shareholder of NewENLRogers, will receive 1.078884 ENL Ordinary A Shares;
- The acquisition by NewENLRogers of 39.15% stake in Rogers from the minority shareholders of Rogers as at date following the buy-out and cancellation of 4,625,890 Rogers Shares on 27 June 2025 under Section 108 to 110 of the Companies Act 2001 through a new issue of 114,017,981 NewENLRogers Ordinary Shares; such that for every share held in Rogers, the minority shareholder of Rogers will receive 1.176979 Ordinary Shares in NewENLRogers;
- The amalgamation of Rogers and Rogers Consolidated Shareholding Limited into NewENLRogers.
